
STEP 1 REMOVE CONTENTS FROM BOX AND VERIFY ALL PART ARE PRESENT. READ INSTRUCTIONS COMPLETELY BEFORE BEGINNING.

STEP 2 REMOVE EXISTING BODY MOUNT BOLTS.

STEP 3 INSTALL FRONT AND REAR BRACKETS AS SHOWN –FIGURE 1

STEP 4 ATTACH STEP BAR AS SHOWN. HAVE TIGHTEN -FIGURE 1.

STEP 5 MAKE SURE STEP BAR AND BRACKETS ARE PROPERLY ALIGNED. TIGHTEN AND TORQUE M12 BOLTS AND ½" HARDWARE TO 63 LBS.
