

## **INSTALLATION STEPS**

- 1. Remove spare tire from vehicle and remove plug located in trunk pan.
- 2. Remove plastic cover on passenger side that attaches vehicle fascia to trunk pan. Return cover and hardware to vehicle owner.
- 3. Center hitch under vehicle and trim passenger side fascia to clear hitch bumper bracket.
- 4. Secure hitch with 1/2" hardware and CM-SP4 spacer through existing hole of plug removed in Step 1. Using hitch as a template drill a 17/32" hole in trunk pan and install remaining 1/2" hardware through trunk pan.
- 5. Using hitch as a template, drill two (2) holes in vehicle bumper beam. Secure hitch with 1/2" hardware and CM-SP4 spacers as shown.

Note: Wagon models require fishwiring bumper hardware through ends of bumper.

- 6. Torque 1/2" hardware to 110 lb-ft. Seal trunk pan holes with silicone sealant.
- 7. Return spare tire to vehicle.
