


## INSTALLATION STEPS

- 1.) Lower exhaust by removing rubber isolators on both driver and passenger side of vehicle. (see rubber isolator removal diagram)
- 2.) Raise hitch into position and install 1/2"- 4" hex bolts and CM-SP34, through the frame rails and side plate of hitch, secure with 1/2" hex flange nuts, as shown above.
- 3.) Fishwire 1/2" carriage bolts and CM-SP12 spacers, through the square access hole in the frame rails and secure with hex flange nuts into position as shown above. (see fishwire technique diagram)
- 4.) Torque all 1/2" hardware to 110 lb-ft.
- 5.) Re-install rubber isolators removed in step 1.
