





INSTALLATION STEPS

- 1. Lower exhaust by removing two (2) rubber exhaust isolators for single exhaust vehicles and four (4) isolators for dual exhaust vehicles. (See RUBBER ISOLATOR REMOVAL DIAGRAM.)
- 2. Remove heat shield(s) by removing four (4) screws per shield. Save screws and shields for reinstallation later.
- 3. If present, remove the underbody panel and trim. Save panel and fasteners for reinstallation later. (See UNDERBODY PANEL TRIM DIAGRAM)
- 4. Check if hardware can be inserted through access holes in frame rails. If not, enlarge the holes with a die grinder or rotary tool until hardware can pass through.
- 5. Fishwire 7/16-14 x 1 1/2 carriage bolts and CM-SP11 spacers through access holes and out mounting holes in both frame rails, as shown. (See FISHWIRE TECHNIQUE diagram.)
- 6. Insert 3/8" U-bolt through tow hook as shown.
- 7. Raise hitch into position and secure it with 7/16-14 hex flange nuts on to carriage bolts and 3/8-16 hex flange nuts on to U-bolt, as shown. If under bodypanel is present you will need to raise it with the hitch.
- 8. Torque all 7/16" hardware to 70 lb-ft and 3/8" hardware to 26 lb-ft. **Note**: If underbody panel is present you will need to reach underneath it to torque the driver side bolt.
- 9. Trim heat shield(s) around hitch. Reinstall heat shields with hardware removed in Step 2. (See HEAT SHIELD TRIMMING DIAGRAM.)
- 10. Raise exhaust and reattach rubber isolators removed in Step 1. If underbody panel is present, resecure using fasteners removed in Step 3.
