

INSTALLATION STEPS

- 1) Lower underbody panel by removing (5) torx head screws. (Trim panel and reuse later).
- 2) Lower exhaust by removing (2) screws from exhaust hanger.
- 3) Fishwire 7/16" carriage bolt and spacer through access hole and out rear most hole in passenger side frame as shown.
- 4) Raise hitch into position over exhaust and secure driver side with (2) hex bolts into the existing weldnuts.
- 5) Using hitch as a template, drill required hole into frame rail for remaining fastener. Fishwire 7/16" carriage bolt and spacer through access hole and into drilled hole as shown. Secure with 7/16" flange nut.
- 6) Torque all M8 bolts to 23 lb-ft and all 7/16" fasteners to 70 lb-ft.
- 7) Replace exhaust hanger removed in step 2.
- 8) Trim rear bumper fascia and underbody panel as shown in illustrations above. Reinstall underbody panel using torx head screws removed in step 1.
