



1. Lower exhaust be removing (2) rubber isolators.





2. Lower evaporation canister on driver side of vehicle by removing (2) hex bolts and slide the canister off of the (2) yellow clips. Remove the yellow clips from the frame rail. Return clips and bolts to vehicle owner.

INSTALLATION WALKTHROUGH:

3. Insert 1/2" carriage bolt and CM-SP40 spacer through the vehicle tow loop. Raise the hitch into position.





4. Secure hitch with supplied M10 hex bolts and 7/16" conical toothed washers. Install 1/2" hex flange nut onto carriage bolt.





5. Reinstall evaporation canister with supplied M8 hex bolts and 5/16" lock washers. Torque 1/2" hardware to 110 lb-ft., M10 hardware to 48 lb-ft and M8 hardware to 23 lb-ft.





6. Raise exhaust back into position.

INSTALLATION STEPS

- 1. Lower exhaust by removing (2) rubber isolators.
- 2. Lower evaporation canister on driver side of vehicle by removing (2) hex bolts. Remove canister by sliding off of yellow plastic hangers. Return bolts to vehicle owner.
- 3. Remove yellow plastic clips from driver side frame rail. Return clips to vehicle owner.
- 4. Install 1/2" carriage bolt and CM-SP40 spacer through vehicle tow loop.
- 4. Raise hitch into position and secure with M10 bolts and 7/16" conical toothed washers into existing weldnuts. Install 1/2" hex flange nut onto carriage bolt.
- 5. Raise evaporation canister and secure with supplied M8 bolts and 5/16" lock washers.
- 6. Torque 1/2" hardware to 110 lb-ft, M10 hardware to 48 lb-ft and M8 hardware to 23 lb-ft.
- 7. Raise exhaust back into position.
