

INSTALLATION STEPS

- 1. This hitch mounts to the driver and passenger side vertical bumper supports and to the center tie-down loop as shown. Temporarily disconnect the rubber exhaust hanger to ease installation.
- 2. **SEDANS ONLY**: Remove the screw on center fascia tab and remove the metal bracket attached to the bumper beam. Trim fascia to remove the center tab. Trim the forward edge of driver and passenger fascia tabs as necessary.
- 3. Hold the hitch in position against the center tie-down loop as shown. Install U-bolt over the tie-down loop and secure with nylock nuts. Use the CM-11148-SP spacer at the tow loop on wagon models only.
- 4. Level the hitch, and using the hitch as a template, mark the hole locations for fasteners. Centerpunch and drill these holes for 7/16" fasteners.
- 5. Install fasteners as shown.
- 6. Torque all 7/16" carriage bolts to 59 ft-lbs. Torque 7/16" U-bolt to 25 ft-lbs.
- 7. Reinstall exhaust.
