



INSTALLATION STEPS

-NO DRILLING REQUIRED -LOWER EXHAUST

- 1. This hitch mounts to the bottom of the right and left frame rails; one threaded hole each side, and to the tow loop located on the car's trunk pan.
- 2. Temporarily lower the muffler/tail pipe by disconnecting the two rearmost hangers if necessary.
- 3. Lift the hitch into position on the bottom of the frame rails, as shown in the diagram, Install as shown. Do not fully tighten.
- 4. Fasten the hitch to the tow loop using fasteners as shown. The backing plate fits to the top of the loop and the hitch bracket fits under the loop.
- 5. Torque all 1/2" fasteners to 110 lb-ft, and all 10mm fasteners to 48 lb-ft.
