


INSTALLATION STEPS

1. This hitch mounts with existing weldnuts to the bottom surface of both frame rails.
2. Under the rear of the car, locate the left and right frame rails. Remove the tie down brackets bolted to these frame rails. Return these to the vehicle's owner for reinstallation should the hitch ever be removed.
3. Lift the hitch into position over the vehicle's exhaust tips. Install fasteners as shown.
NOTE: Some models may need the plastic tabs to be trimmed slightly to align the mounting holes.
4. Torque all 10mm fasteners to 48 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
