

3) Using hitch as template drill 1/2" hole in the slotted hole toward front of vehicle in side plate, on the passenger's side.

4) Fishwire carriage bolt and block through access hole on bottom of frame rail.

5) Install remaining fasteners as shown. Torque all 1/2" hardware to 110 lb.-ft.
