INSTALLATION STEPS

1) Remove trunk insert.

- SEAL TRUNK PAN

- 2) Remove (2) trunk body plugs.
- 3) Place 2" carriage bolt into large square hole spacer.
- 4) Fit carriage bolt and spacer into tow loop (as shown).
- 5) Lift hitch into position and fasten to tow loop using 1/2" flange nut.
- 6) Push hex bolts through hitch and into the trunk pan. Fasten with square hole spacers and flange nuts.
- 7) Torque all 1/2" fasteners to 110 lb-ft.
- 8) Seal trunk, using silicone calk around interior flange nuts.
