

**INSTALLATION STEPS**

- 1) Lower exhaust by remove (2) 8mm nuts on exhaust bracket.  
(Leave rubber hanger on exhaust and return bracket to customer.)
- 2) Charcoal canister on driver side may need to be lowered on some models.
- 3) Lift hitch into position and secure with 10mm bolts and 8mm nuts as shown. (Finger tighten only.)
- 4) Starting with the 10mm bolts on the side of the frame rail, torque all 10mm fasteners to 48 lb-ft and 8mm fasteners to 23 lb-ft.
- 5) Reinstall exhaust on new hanger mount as shown.

**PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.**
