





INSTALLATION STEPS

- 1) Remove (10) plastic fascia fasteners. (re-use later)
- 2) Raise hitch into position by pulling down on fascia and positioning hitch behind bumper cover.
- 3) Center hitch by placing towhook between hitch mounting tabs. Secure using a 1/2" carriage bolt and flange nut.
- 4) Using hitch as a template, mark and drill (2) 1/2" holes through bumper beam.
- 5) Fishwire 1/2" bolts and spacers from ends of bumper beam, through drilled holes and hitch. Secure with flange nuts as shown.
- 6) Torque all 1/2" fasteners to 110 lb-ft.
- 7) Reinstall plastic fascia fasteners removed in step (1).
