





### **INSTALLATION WALKTHROUGH:**




1) Fishwire the four (4) 1/2-13 carriage bolts and the CM-SP6 spacers into the vehicle frame through the access holes as shown. Refer to the "Fishwire Technique" diagram.





- 2) Raise the hitch into position, being careful not to push the bolts up into the vehicle frame.
- 3) Remove the fishwire from the bolts and secure the hitch into position using the 1/2-13 hex flange nuts.



### **INSTALLATION STEPS**

- 1) Fishwire the four (4) 1/2-13 carriage bolts and the CM-SP6 spacers into the vehicle frame through the access holes. Refer to the "Fishwire Technique" diagram.
- 2) Raise the hitch into position, being careful not to push the bolts up into the vehicle frame.
- 3) Remove the fishwire from the bolts and secure the hitch into position using the 1/2-13 hex flange nuts.
- 4) Torque all 1/2-13 fasteners to 110 lb-ft.
