



INSTALLATION STEPS

- 1) Remove spare tire from trunk, remove rubber plugs.
- 2) Install trunk pan spacer with (2) 1/2" carriage bolts.
- 3) Enlarge two holes in bumper beam which line up with outer two holes in hitch plate.
- 4) Fishwire (2) 7/16" carriage bolts with SP7 spacers from end of bumper beam to enlarged holes.
- 5) Raise hitch into position and finger tighten in place with (2) 1/2" and (2) 7/16" flange nuts.
- 6) Torque all 7/16" hardware to 59 ft.-lb. and all 1/2" hardware to 110 ft.-lb.
- 7) Return spare tire to trunk.
