


INSTALLATION STEPS

1. If present, lower carbon canister and bracket from passenger side frame rail.
2. Remove tie down brackets from vehicle frame rails.
3. Remove rubber isolator from from mounting bracket on driver's side frame rail. Remove mounting bracket from frame rail. (Return tie-down brackets and exhaust mounting bracket with fastener to vehicle owner.)
4. Raise hitch into position and loosely install existing M12 hardware, being sure to re-install carbon canister bracket as shown.
5. Push hitch toward driver's side and torque all M12 fasteners to 68 ft-lbs.
6. Attach rubber exhaust isolator to driver's side hitch plate as shown using provided 7/16" hardware and tighten until bolt threads protrude through nylock nut.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
