



INSTALLATION STEPS

- 1. Using a small flat screwdriver, unclip the center underbody panel from the rear bumper fascia.
- 2. Pull rear of center underbody panel down enough to allow acces to nuts holding panel to vehicle trunk pan.
- 3. Using a 10" socket extension, universal joint adapter, and 10mm socket, remove three (3) factory nuts holding center underbody panel to the vehicle trunk pan.
- 4. Remove center underbody panel. Return panel and nuts to vehicle owner.
- 5. Remove two (2) bolts from inside of bumper beam on both driver and passenger side of vehicle. Return bolts to vehicle owner. (See BUMPER BEAM BOLT REMOVAL DIAGRAM.)
- 6. Remove one (1) bolt from center of trunk pan. Return bolt to vehicle owner.
- 7. Raise HITCH ASSEMBLY into position. Install supplied M10-1.50 x 30mm bolts and 3/8 in. conical toothed washers through HITCH ASSEMBLY, as shown.
- Secure MOUNTING STRAP ASSEMBLY to HITCH ASSEMBLY with 7/16 in. carriage bolts and hex flange nuts, as shown.
- 9. Secure MOUNTING STRAP ASSEMBLY to trunk pan with M10-1.50 x 35mm bolt and 3/8 in. conical toothed washer, as shown.
- 10. Torque M10-1.50 hardware to 45 lb-ft and 7/16 in. hardware to 70 lb-ft.
