

INSTALLATION STEPS

- 1. Remove all contents from the spare tire well. Locate and mark the vehicle's centerline so the hitch is centered on the rear bumper.
- 2. Cut away the vehicle's plastic fascia to clear the hitch bracket at the bumper beam. With the hitch in place as shown, centered and square with the vehicle, mark and center punch the bumper and the trunk floor for holes.
- 3. Drill (4) holes in spare tire well for 3/8" diameter hardware. Drill (2) holes in bumper beam for 7/16" hardware.
- 4. Install U-bolt in bumper following the diagram. NOTE: Holes in bumper beam may be worked slightly larger if necessary to get the U-bolt into the bumper. Mount the hitch using fasteners as shown. Fender washers must be installed inside the vehicle, opposite the hitch.
- 5. Torque all 3/8" fasteners to 45 lb-ft and all 7/16" fasteners to 70 lb-ft.
- 6. Use silicone sealant to seal hardware installed through spare tire well.
- 7. Reinstall contents removed from spare tire well in Step 1.
