INSTALLATION STEPS

- 1. Remove the license plate, and clear the trunk area. Locate and mark the car's centerline on the rear bumper channel.
- 2. Assemble the hitch tail bracket to tongue through the center hole using fasteners shown. Hold the hitch centered and level against the car so that the spacer tubes (see diagram) rest against the bumper channel. Mark the license plate cavity and bumper channel for two 3/4" clearance holes for spacer tubes. Drill the bumper channel and plate cavity for spacer tubes.

NOTE: Clearance holes may not fall centered on the channel.

- 3. Position the hitch on the car with spacer tubes passing through the license plate cavity and bumper channel. Drill the rear panel for two 3/8" diameter holes by drilling directly through the spacer tube. Use fasteners as shown and bolt the hitch to the rear panel making sure to use flat washers on BOTH sides of panel.
- 4. Drill the trunk floor two places through hitch tail bracket for 3/8" bolts. Fasten the hitch to the floor. Make sure fender washers are installed INSIDE the vehicle, opposite the hitch.
- 5. Torque all 3/8" fasteners to 45 lb-ft.
- 6. Use silicone sealant to seal hardware installed in trunk.
- 7. Reinstall spare tire and license plate.
