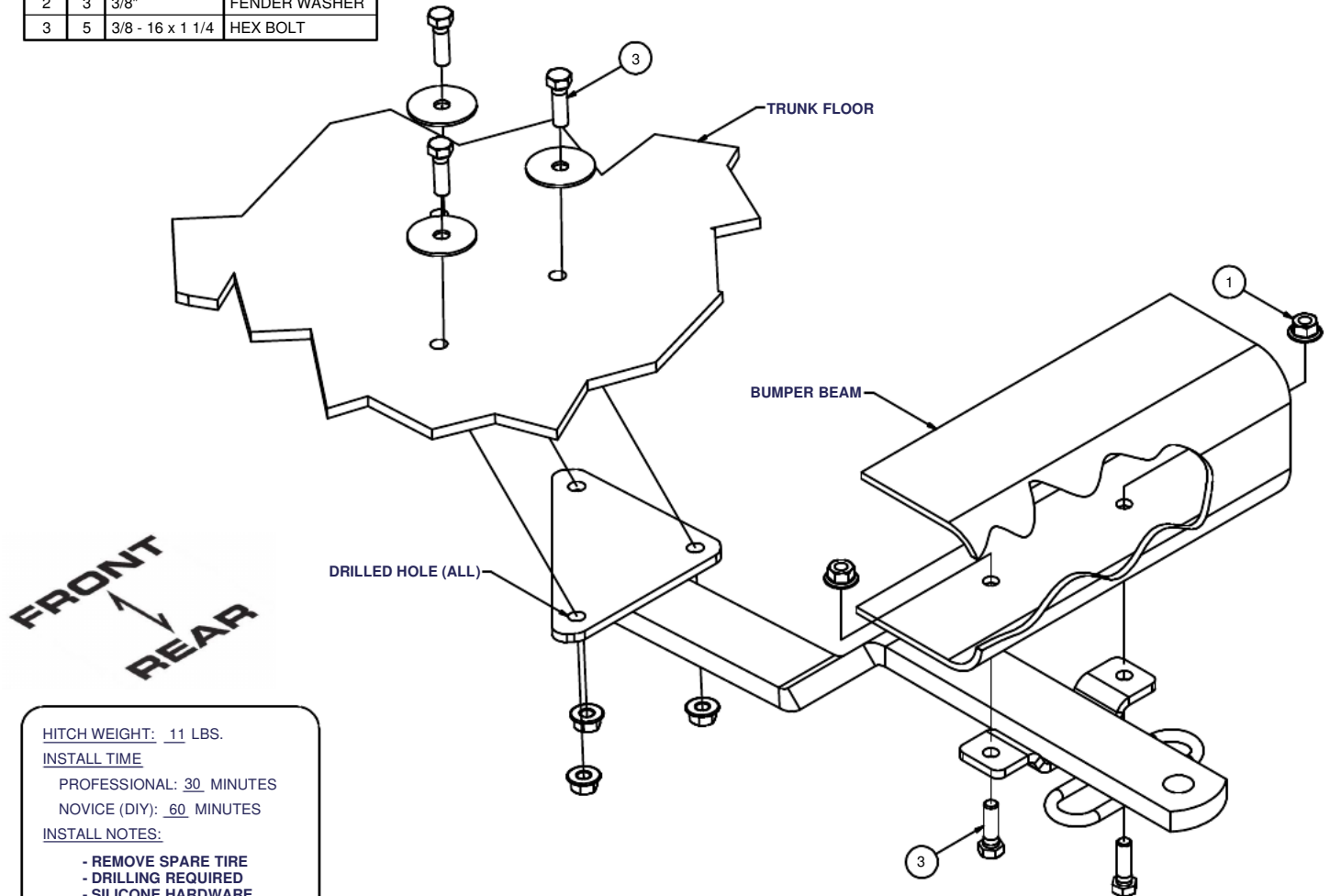

- SILICONE HARDWARE

INSTALLATION STEPS

1. Remove spare tire. Position the hitch against the underside of trunk floor(spare tire well) and rear bumper as shown. Adjust the front/rear for bumper clearance.
2. Using the hitch as a template, mark and drill (3) places in trunk floor and (2) places in rear bumper surface for 3/8" bolts.
3. Fasten hitch into position. Be sure to use fender washers opposite the hitch as shown.
4. Torque all 3/8" fasteners to 45 lb-ft.
5. Use silicone sealant around fasteners in floor pan to seal out water and exhaust fumes.
6. Reinstall spare tire.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
