

## **INSTALLATION STEPS**

- 1. Remove the rear bumper by removing (4) to (6) screws located inside the trunk / hatch area or under the vehicle near the bumper bracket. Also check for small screws located at the ends of the bumper in the fender well and remove them.
- 2. Locate and remove the metal U-channel at the bottom of the rear bumper fastening the rubber cover to the bumper. A 6-7" piece must be removed from the center of this channel before it is reinstalled.
- 3. Trim the rubber bumper cover and crush the interior bumper material to allow the hitch bracket to fit directly on the steel part of the bumper centered across the vehicle.
- 4. Using the hitch as a template, mark the metal bumper beam for drilling. Drill (1) hole for 1/2" hardware through face of bumper beam and drill (2) holes for 3/8" hardware through bottom of the bumper beam.
- 5. Installed hardware as shown.
- 6. Torque all 3/8" fasteners to 45 lb-ft, and all 1/2" fasteners to 110 lb-ft.
- 7. Reinstall the rear bumper in reverse order.
