

INSTALLATION STEPS

- 1) Fishwire 7/16" carriage bolts and spacers through access holes in each frame rail.
- 2) Raise hitch into position aligning holes in hitch to previously fishwired bolts.
- 3) Fasten hitch to frame rail using 7/16" flange nuts.
- 4) Hang U-bolt from tow hook as shown and fasten to mounting plate on forward side of hitch using 7/16" flange nuts.
- 5) Torque 7/16" carriage bolts to 59 lb.-ft. Torque 7/16" U-bolt to 25 lb.-ft.
