

INSTALLATION STEPS

- 1. This hitch includes a tubular center section and driver / passenger side telescoping end brackets mounting to the center section and to the vehicle's tie down loops. Installer must insert end brackets into center section and drill each end bracket with 13/32" diameter holes through center section tube holes and fasten as shown. BEFORE drilling, make certain end brackets are oriented as shown in diagram and measurement across 5/8" diameter in end brackets match center to center distance between tie down loops.
- After bolting hitch end brackets to center section, position hitch on vehicle tie down loops as shown.
 NOTE: 2+2 car requires using CM-11703-BBWA (ITEM 1) spacer. Two passenger car requires using CM-11703-BPWA (ITEM 2) spacer directly against end brackets as shown.
- 3. First fasten hitch to loops using fasteners and spacers as shown. Using the hitch as a template, drill tow loops for 3/8" hardware. Install hardware as shown. NOTE: Backing plates/brackets must be in place to have full attaching strength of hitch.
- 4. Torque all 5/8" hardware to 210 lb.-ft. and all 3/8" hardware to 45 lb.-ft.
