### **INSTALLATION STEPS**

- 1. Under the driver's side rear of car, locate and unbolt two 8mm screws holding the rear-most exhaust support bracket to the chassis. Vehicles with dual exhaust, also remove on passenger side. Note: For Mitsubishi 3000GT, remove left and right tie down brackets (large plate with slotted hole) at same location on car. These brackets are fastened to chassis with two 10mm screws each.
- 2. Lift hitch into position on car with hitch side brackets fitting in area where car's exhaust brackets were previously removed. Install 10mm fasteners as shown. Install bumper brackets and hardware as shown.
- 3. Torque all 8mm hardware to 23 lb.-ft. and all 10mm hardware to 48 lb.-ft.
