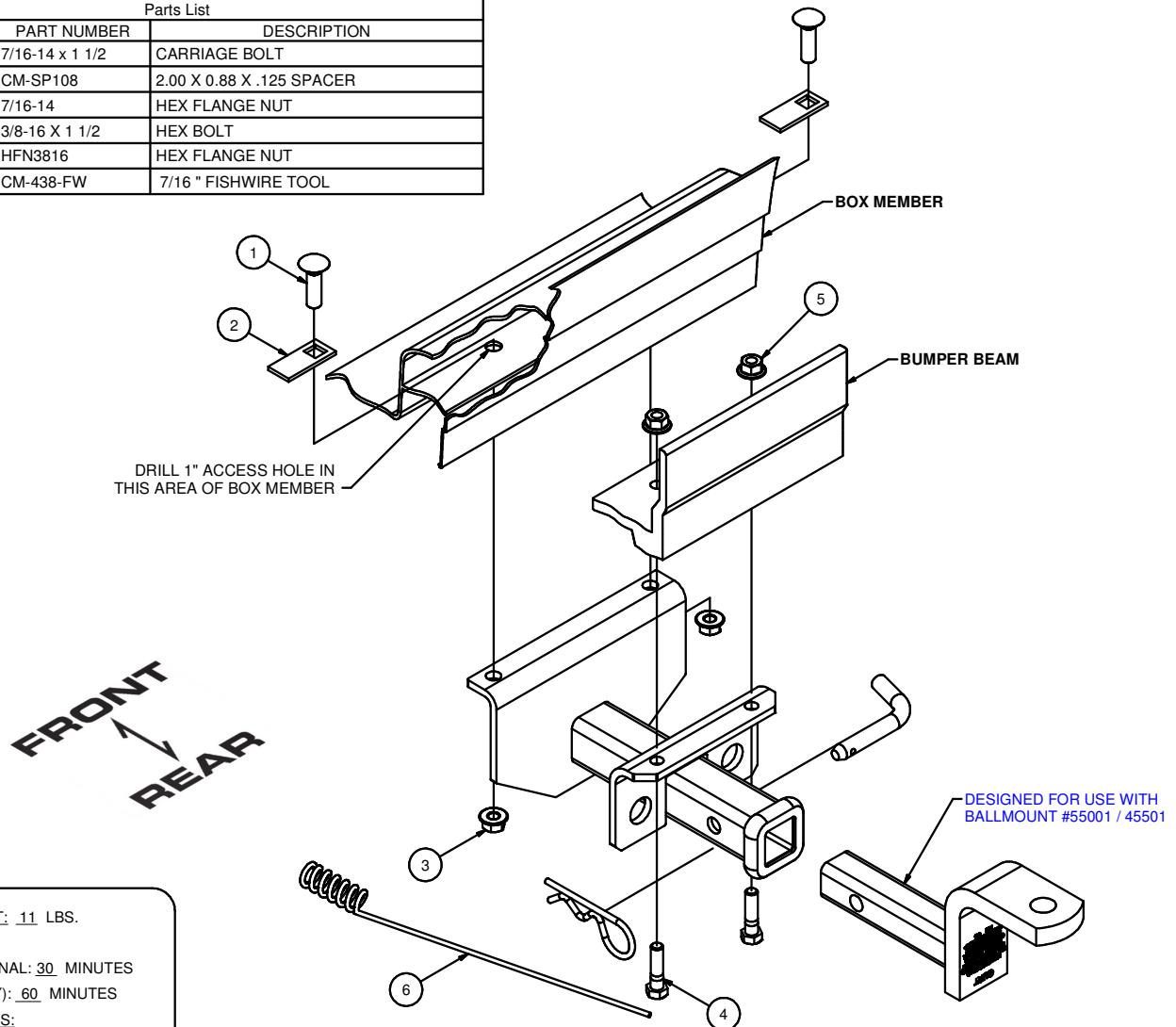

INSTALLATION STEPS

1. Center and square the hitch on the car bumper beam and box member. Using the hitch as a template mark and drill box member using a 1/2" drill. Mark and drill aluminum bumper beam using a 3/8" drill.
2. Drill a 1" diameter access hole in the bottom surface of the box member for hardware using a hole saw. Position the access hole between the 1/2" mounting holes. Fishwire carriage bolts and spacers through the access hole and out 1/2" holes. Cover access hole with duct tape to seal hole.
3. Carefully position hitch over fasteners and secure with flange nuts. Secure hitch to bumper beam with hex bolts and flange nuts. Bumper fascia can be trimmed for access to bolts.
4. Torque all 7/16" hardware to 70 lb.-ft. and all 3/8" hardware to 45 lb.-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
