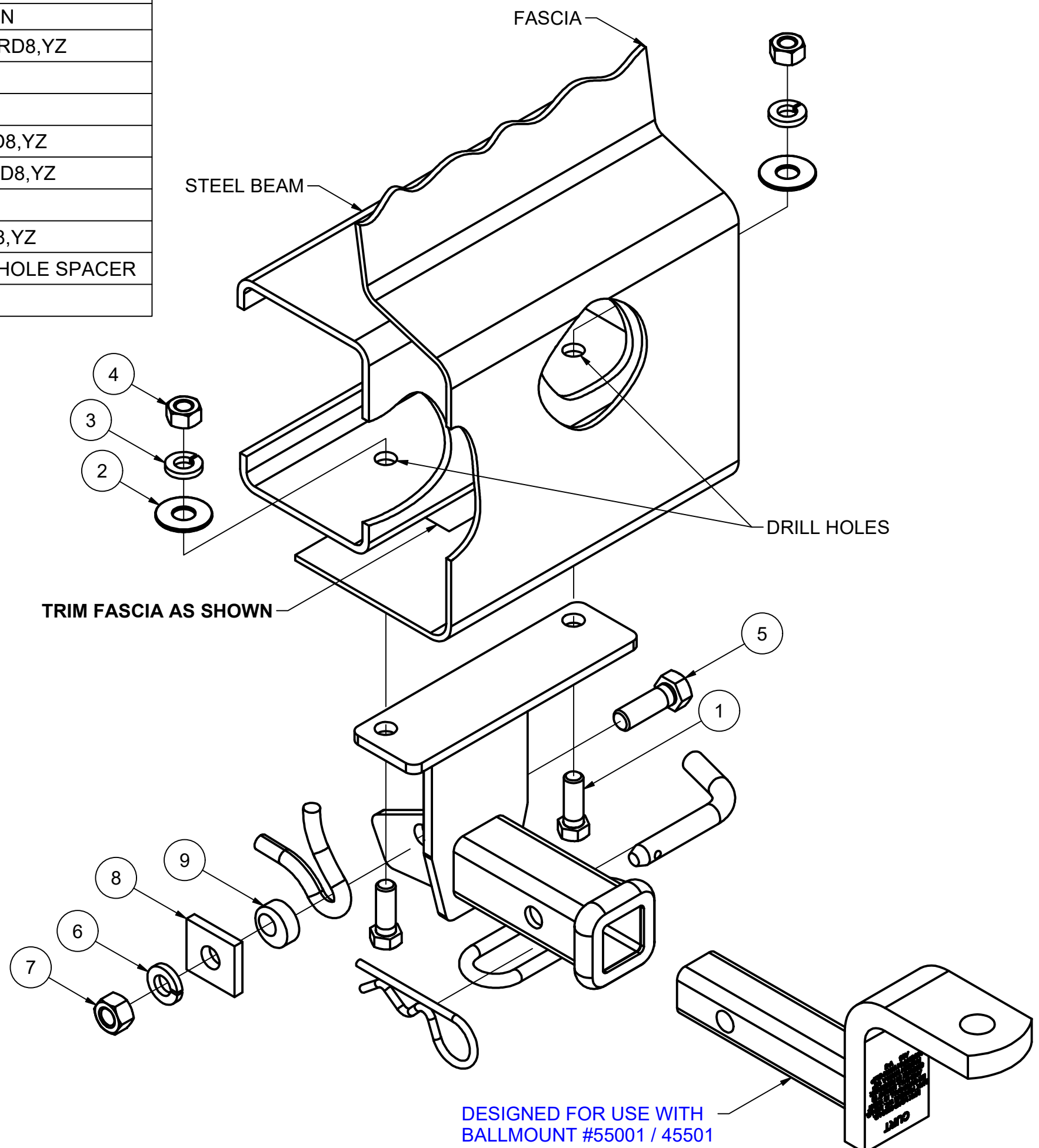

**INSTALLATION STEPS**

1. This hitch will bolt to the bottom of the steel reinforcement beam inside the vehicle's rear bumper, and to the vehicle's tow loop.
2. Before the hitch can be fitted, temporarily remove two bolts fastening the bottom of the bumper fascia to the body. Remove a 2 1/2 x 3 1/2 section of bumper fascia for hitch clearance as shown.
3. Hold the hitch in position on the vehicle at the tow loop and bottom of the bumper beam. Mount the hitch at the tow loop using fasteners as shown. Using the hitch as a template, drill the bumper for 7/16" diameter fasteners.
4. Fasten the hitch at the bumper beam using fasteners as shown.
5. Torque all 1/2" fasteners to 110 lb-ft, and all 7/16" fasteners to 70 lb-ft.
6. Reinstall bumper fascia removed in Step 2.
