- 2. Mark and center punch the centers of the backing plate holes on spare tire well. Drill holes and install hardware through backing plate and hitch as shown.
- 3. Using the hitch as a template, drill remaining mounting holes through spare tire well and install fasteners as shown.
- 4. Torque all 7/16" hardware to 70 lb.-ft.
- 5. Use silicone sealant to seal around hardware in the spare tire well.
- 6. Reinstall contents removed in Step 1.
