

INSTALLATION STEPS

- 1. Position hitch under the rear bumper and align tow hook between the holes at "C"
- 2. Using the hitch as a template mark and drill the holes at "B" (If you have a 2 door model then you must drill two 1" holes at "A" approximately 3.5" to the outside of the holes at "B". see diagram)
- 3. Insert the handle nuts through either the existing holes (4 door) or 1" drilled holes (2 door) and position over holes in the bumper. Place the 1/2" lock washers onto the 1/2" bolts as shown. Place bolts up through the holes in the hitch and bumper at "B" and thread into handle nuts. **DO NOT TIGHTEN AT THIS TIME.**
- 4. Hook 7/16" U-bolt through tow loop and insert into holes at "C". Place flat washer and lock nut onto each side and finger tighten evenly. (*NOTE* A 1/4" thick spacer has been included to be use to level the hitch if needed.)
- 5. Tighten 7/16" U-bolt to 25 ft-lbs and 1/2" fasteners to 110 ft-lbs. **DO NOT USE IMPACT WRENCH ON U-BOLT!!**
