## INSTALLATION STEPS

1. This hitch mounts to the rear bumper beam reinforcement at existing holes. Special washer faced handle nuts are placed inside the beam through existing access holes.
2. Locate (2) threaded ( 10 mm ) holes in the forward face of beam making sure the threads are clean. Loosely install the hitch at threaded holes using fasteners as shown.
3. Install fasteners through the bottom of the bumper beam with lock washers up though the hitch bracket and existing holes in the bottom of the beam. If necessary, these holes may be enlarged to make fit up easier. Place handle nuts though access holes as shown to engage screws.
4. Torque all $3 / 8$ " fasteners to $45 \mathrm{lb}-\mathrm{ft}$, and all 10 mm fasteners to $49 \mathrm{lb}-\mathrm{ft}$.
