



WELDNUT CLEANING

To remove debris from weldnuts in frame, spray lubricant or compressed air into hole. For heavy debris, use a small wire brush. (Be careful not to damage threads).

INSTALL NOTES:

- NO DRILLING REQUIRED

INSTALLATION STEPS

- 1) Raise hitch into position and align holes on hitch with holes in frame rail.
- 2) Install rearmost bolts hand-tight to secure hitch to frame.
- 3) Insert bent handle nuts as shown and install remaining hardware.
- 4) Torque M12 hardware to 86 lb-ft. and all 1/2" hardware to 110 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
