

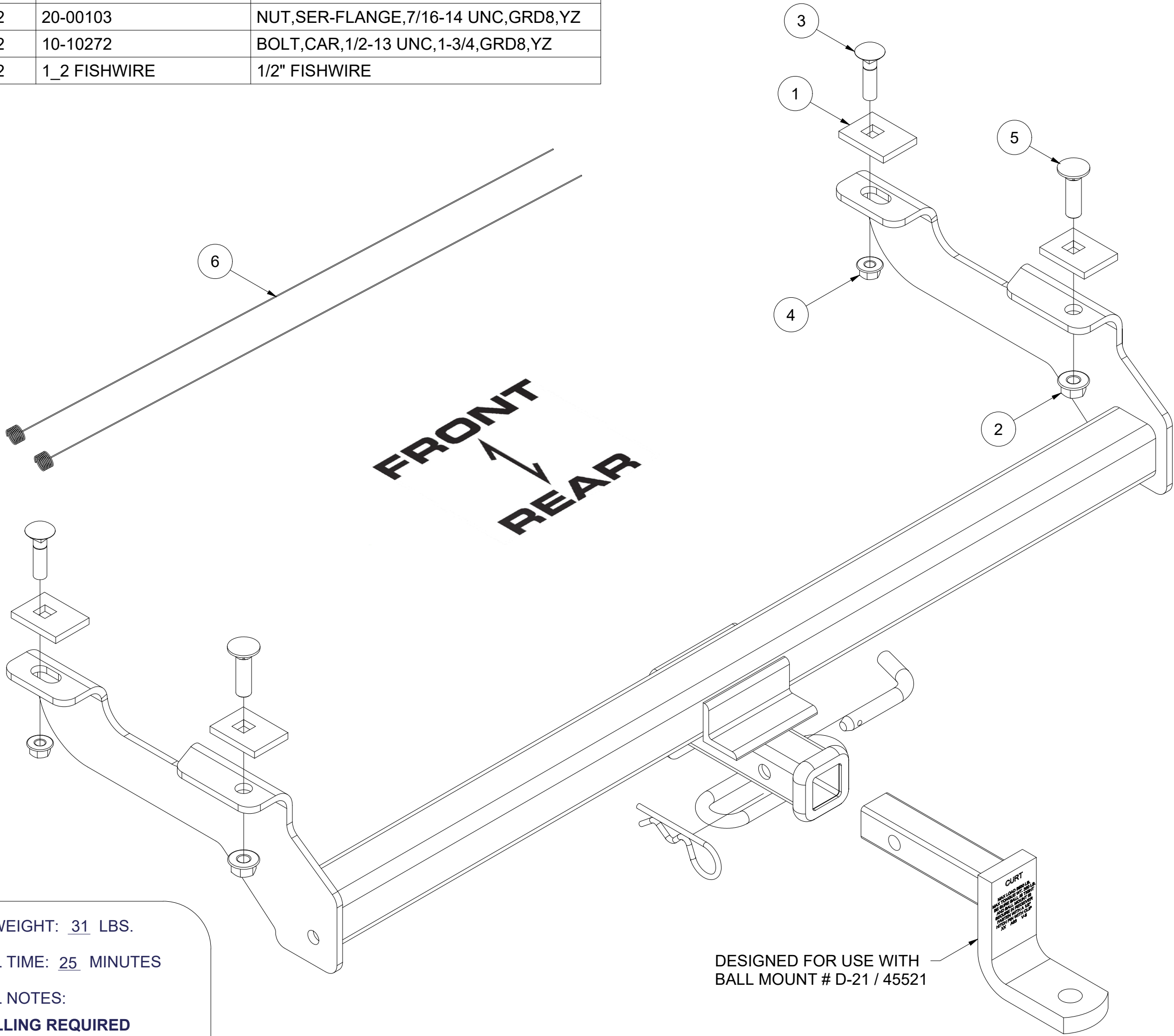

INSTALLATION STEPS

- 1) Raise the vehicle for access to the underside.
- 2) Fishwire 1/2 x 1.75" carriage bolt and square hole spacer through the access hole in the rear of the vehicle frame and out through the front hole in the frame rail. Repeat this procedure for the second slotted hole with 7/16 x 1.75" carriage bolt and square hole spacer.
- 3) Raise the hitch into position and be careful not to push the carriage bolts back into the frame rail.
- 4) Install 1/2" flange nuts and hand tighten.
- 5) Torque all 1/2" fasteners to 110 lb-ft, and all 7/16" fasteners to 70 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
