



WELDNUT CLEANING

To remove debris from weldnuts in frame, spray lubricant or compressed air into hole. For heavy debris, use a small wire brush. (Be careful not to damage threads).

INSTALLATION STEPS

- 1) Raise hitch into position over the exhaust. Align the slots in the hitch with the weldnuts in the frame rails closest to the rear end of the vehicle.
- 2) Install hex bolts and conical toothed washers into weldnuts.
- 3) Torque bolts to 86 lb-ft.

PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
