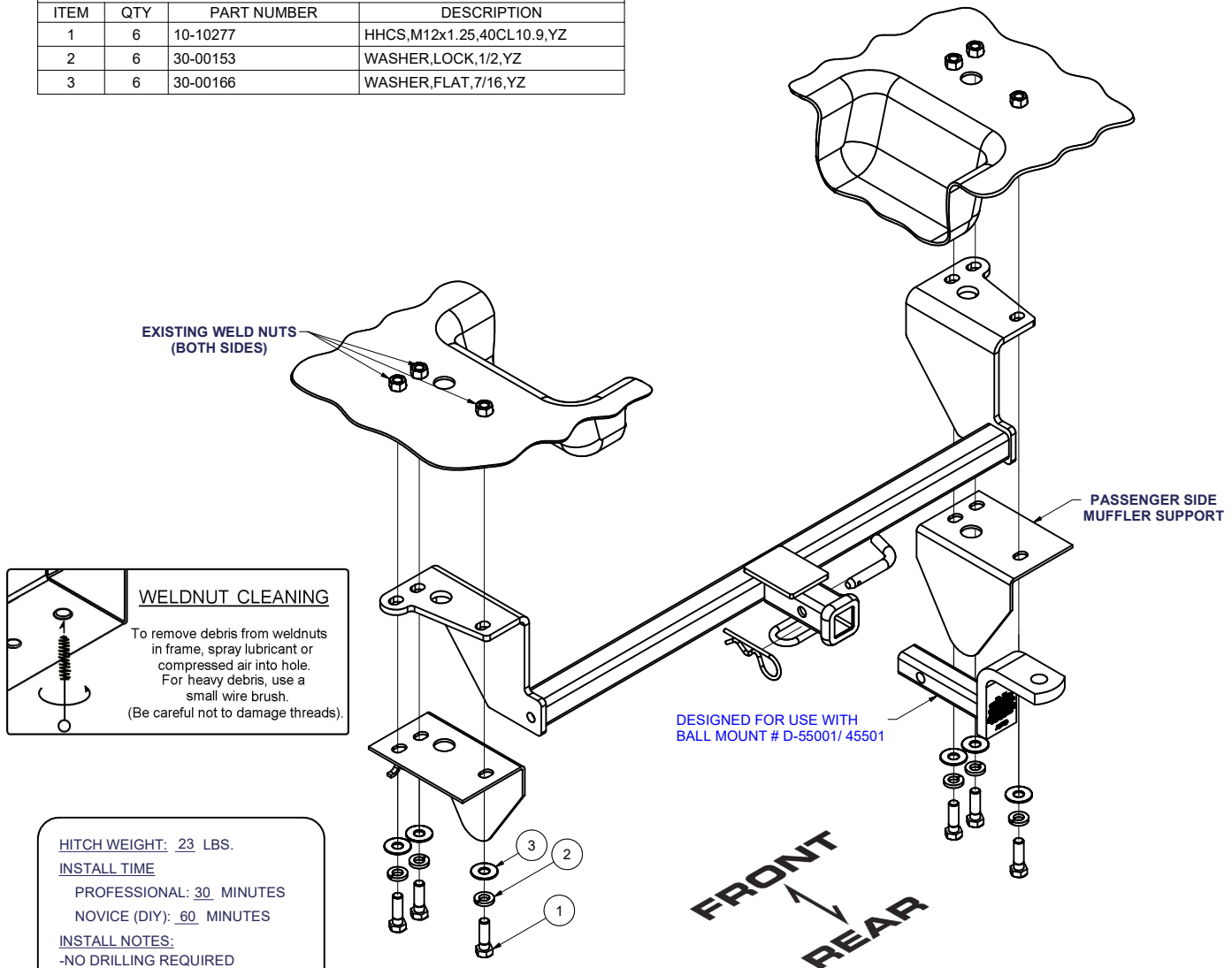

**INSTALLATION STEPS**

1. Under the rear of the car, locate the exhaust mufflers on the driver and passenger sides of the car. The mufflers are supported at the rear of the vehicle by flexible supports and brackets bolted into the chassis with three 12mm screws per bracket.
2. Temporarily remove these brackets from the chassis on the driver and passenger sides of the car. Position the hitch on the vehicle at the same mounting points. Remount these brackets at the bottom of the hitch brackets on both sides of the vehicle. Mount the hitch using fasteners provided.
3. Torque all 12mm fasteners to 86 lb-ft.

**PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.**
