





INSTALLATION STEPS

- 1) Remove the (2) plastic fascia nuts from the fascia tabs. (Do not discard.)
- 2) Lower exhaust by removing the bolts holding the exhaust hangers on both sides. (See RUBBER ISOLATOR REMOVAL DIAGRAM)
- 3) Remove the (4) plastic nuts at the bottom of the trunk holding the heat shield in position. Gently pull the heat shield away from the frame rail to allow access to the frame rails. (Note: The heat shield cannot be removed.)
- 4) Remove the tape covering the holes on the side of the frame rails.
- 5) Using the access hole at the end of the frame rail (before the impact bar), fishwire the carriage bolts and spacers into position. Leave the fishwires attached to the carriage bolts. (See FISHWIRE TECHNIQUE)
- 6) Push the carriage bolts back into the frame rail leaving the fishwire and the extra wire sticking out between the frame rail and trunk.
- 7) Raise the hitch into position between the frame rails. Feed the fishwires through the adjacent holes in the hitch. Point the receiver tube down and rotate it into position through the fascia exhaust cut out. (Above the heat shield and muffler.) Be careful not to scratch the fascia. If excess caulking on the frame rail interferes with the installation lower the hitch and scrape off the excess caulking for installation.
- 8) Pull fasteners into position through the mounting holes and hitch.
- 9) Remove fishwires and secure using the hex flange nuts. (Be careful not to push the carriage bolts into the frame rails.)
- 10) Torque all 7/16-14 hardware to 59 lb-ft.
- 11) Bend heat shield back into position and reinstall heat shield plastic nuts removed in Step 3.
- 12) Raise exhaust sytem back into place and secure using the fasteners removed in Step 2.
- 13) Reinstall plastic nuts into bumper fascia. (removed in Step 1)
