1) Remove tow-hook and fasteners.

WARNING: DO NOT INSTALL TOW-HOOK WITH HITCH IN PLACE.

- 2) Position hitch on vehicle as shown. Align holes in hitch with existing weldnuts in vehicle frame (driver's side) and tow-hook mounting pad (passenger's side). Loosely install fasteners as shown.
- 3) Using hitch as a template, drill 1/2" hole through forward hole in driver's side plate into frame.
- 4) Install handle nut through end of frame and install remaining fasteners as shown.
- 5) Torque M10 fasteners to 48 lb.-ft., M12 fasteners to 86 lb.-ft., 7/16" fasteners to 59 lb.-ft., and all 1/2" fasteners to 110 lb.-ft.
