



# **INSTALLATION STEPS**

- 1) Remove existing 14M fasteners from end of each frame rail if present and return to customer.
- 2) Trim bumper fascia as needed for access to weldnuts in bumper and clearance for bumper mount.
- 3) Lift receiver into position, locating slots in hitch over weldnuts in vehicle frame.
- 4) Install 14M fasteners through hitch into weldnuts in vehicle frame and bumper.
- Note: Install (1-4) 9/16" washers per side between hitch and bumper attachment as needed for variations in bumper height.
- 5) Torque all 14M fasteners to 126 lb-ft, and all 1/2" fasteners to 110 lb-ft.

### PERIODICALLY CHECK THIS RECEIVER HITCH TO ENSURE THAT ALL FASTENERS ARE TIGHT AND THAT ALL STRUCTURAL COMPONENTS ARE SOUND.
